REALTORS® are required to complete ethics training within three-year cycles. The National Association of REALTORS® requires that all members take Code of Ethics once they join a Board. The Code is what sets REALTORS® apart from other real estate professionals. When you take the Code of Ethics class, you are stating that you will follow a strict Code of Ethics promoting professionalism and an ethical real estate practice.

Every REALTOR is required to take Code of Ethics every three years. New members are required to take Orientation/Code of Ethics within
